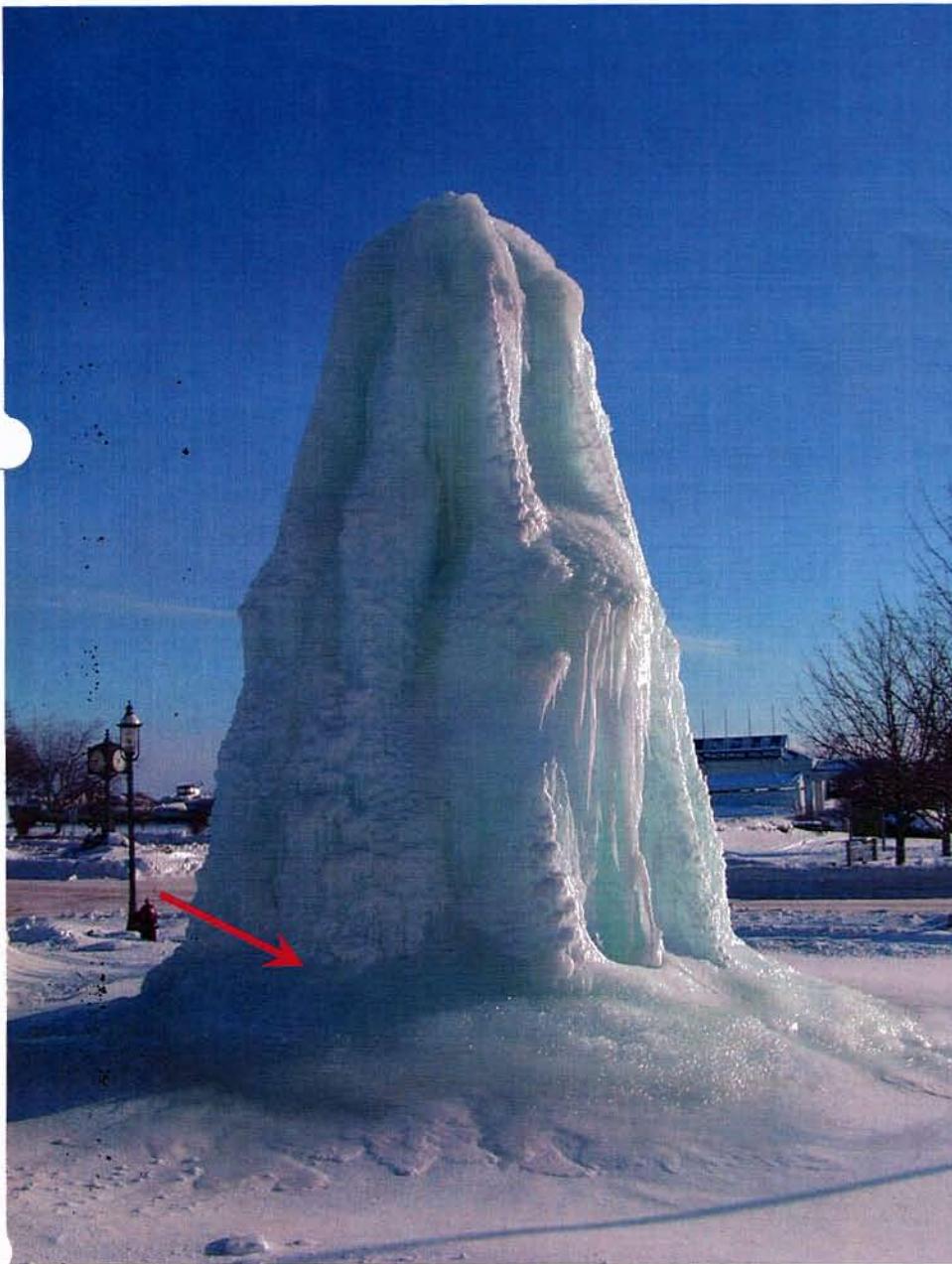


# WHEN WILL THE ICE MELT?

**Ice tower rules - January 15, 2008**

1. The organization responsible for this contest is the Mackinaw Area Historical Society (MAHS).
2. The contest involves guesses regarding when the ice on the tower will sufficiently melt to allow an electronic device, placed within the ice, to drop, deactivating a recorder which is logging date, hour (am/pm), minute and second. **Need not be present to win.**
3. Chances may be purchased from authorized sellers and at various locations in Mackinaw City and the Straits Area. Ticket sales end Midnight, April 1, 2008.
4. Chances will be two for \$5.00 (Five dollars). Special envelopes will be available from those listed in 3 above.
5. Winner(s) will receive fifty percent (50%) of all proceeds or \$1,000 (One thousand dollars), whichever is greater. Remaining proceeds are the property of MAHS.
6. MAHS is not responsible for lost, illegible or stolen entries. Entries without entry fee will be disqualified.
7. If the recorder should be interrupted by vandalism, power failure or other events beyond MAHS control, it will be reset.
8. Winner(s) are not determined by "last ice to melt" - See 2 above.
9. MAHS will attempt to notify winner(s) within 48 hours by telephone. If unable, notice will be sent to address on entry form.
10. Winner(s) have 90 days from winning date to claim prize or instruct MAHS on appropriate forwarding.
11. Ice Tower Classic Committee members, Executive Board members, and their immediate households are ineligible to participate. Executive Board is defined as: President, First Vice President, Second Vice President, Secretary and Treasurer of MAHS.
12. No refunds will be provided.
13. Committee decisions regarding determination of winner(s) are final
